Hi Alfonso,

I have good news and bad news. The good news is that I found Cornell02 data for 2009 and there were 10 collecting events. I have updated the farm time area file appropriately. The bad news and - probably a good thing - is that the original data set included both transects and general collections. A general collection spanned 30 minutes with no specific area. So we can either add the time per study that the general collection represents and assume we walked the same pace for general collections as transects. Or abundances would need to be recalculated without general collections. I don't personally have time to recalculate abundances, but I can see if Bryan has someone in his lab who does OR I can send you our data raw files with each row as a collection event (transect) and species as columns with abundance for each transect in a cell. I can clean these files up so they don't include the general collections. You guys are data gurus, so you may very easily extract the needed data from the raw files. Let me know how you would like to proceed. I will follow up with Bryan - coauthor - in the meantime. So sorry but glad we caught this.

Please find attached my response to your summary report and queries and supporting documents. I am unable to edit a pdf directly, so I copied the queries and added my answers into word - see "Park\_Summary\_report\_and\_queries."; I also provide excel files of data requested. Your processing of the data is correct, but I found a couple errors on our end. Please delete the following field sites from our data set:

2009 Hemlock01  
2011 BartlesonHill  
2011 LittleTree

According to my records, these were not surveyed according to protocol. You will see the numbers are very low or 0. I am unable to provide bloom density, but have calculated time and area for visitation data.

You will see a note about management. Our orchards are either organic or IPM. Within IPM the U-pick farms sprayed far less than the commercial operations. Don't know if you have a way to take that into consideration.

Good luck pulling all your data sets together and finalizing the manuscript.
